Executive Summary

Gateway's community assessment is a comprehensive document that provides the quantitative and qualitative data needed to make informed decisions about the jurisdiction in which Gateway operates. The community assessment is a process that is defined by our ROMA cycle, which establishes timelines for completion as well as implementation, tracking of progress, and evaluative action. Timelines depict the process; ensuring activities occur on a predictable timetable and provide adequate time for collecting, aggregating, and analyzing data that frames a unique view of the varying resources and challenges specific to each county as well as the agency as a whole. Mining relevant data is critical to accessing the agency's mission and providing a springboard for the development of the agency's short-term and long-range goals, which are articulated in the strategic plan.

The full community assessment is completed on a triennial basis. The strategic plan is reviewed annually and undergoes a full update on a quinquennial basis. The community assessment data is reviewed annually to determine if significant changes have occurred within the agency's jurisdiction that would warrant an update to one or more of the areas. The compilation of the assessment, along with subsequent reviews and updates as necessary are documented through agenda's, sign-in sheets, and minutes.

The board of directors are actively involved in the process, and formally accept the community assessment on a triennial basis, as well as any subsequent changes and/or updates that may occur during the three-year period.

Quantitative data is derived from various sources, which are cited for future reference. Collected data includes information on poverty and its prevalence to gender, age, race/ethnicity, and is inclusive of required data specific to programs such as CSBG, Head Start, and Early Head Start.

Qualitative data is derived from consumer surveys, forums, and random calls, along with board of directors, policy council, employee, and community partner surveys. Qualitative data coupled with statistical data provides a holistic view and provides the venue for cross-referencing to determine if the quantitative data supports what the key stakeholders believe to be true. Both pieces of data provide a powerful tool for continuous agency improvement.

Aggregated data is taken under review by Gateway's data analysis team, where a draft of key findings are developed that provides information on the potential causes and conditions of poverty within the jurisdiction. Understanding the needs, resources, and challenges of each community permits the agency to deliver services that will promote the best possible outcomes, thus, allowing decision makers to be good stewards of local, state, and federal dollars.

The community assessment provides information related to the needs and resources which culminates into a planning process that results in the development of a five-year strategic business plan that drives the implementation of agency initiatives, the achievement of established goals, and the ongoing evaluation and reporting of progress, which depicts the Results Oriented Management & Accountability (ROMA) cycle.

KEY FINDINGS


Quantitative Data:

- State population shows the highest age range falls between 18 - 64, illustrating communities that are thriving *(Community)*
- Bath and Montgomery counties have seen the greatest growth with Rowan next, Menifee to follow, and Morgan showing a decline in population *(Community)*
- Bath county exceeded the state average in growth among children under five (5) years of age *(Family)*
- The median income in the state is close to \$15,000 less than the national average, supporting the need for higher wage job opportunities *(Family)*
- The median household income is lower than the state average in all counties with the lowest income reported in Menifee and Morgan counties *(Family)*
- Children living in deep poverty rates in Menifee and Morgan counties are significantly higher than the state average *(Family)*
- The number of children living in foster care are higher in all Gateway counties with numbers in Rowan doubling the state average *(Family)*
- Incarcerated youth in Menifee county exceeded the state rate *(Family)*
- The number of children receiving health insurance has steadily increased over the last five (5) years in all Gateway counties *(Family)*
- Married couple families, as defined by the census data, are the highest income earners *(Family)*
- The rate of Individuals with a high school diploma or GED is higher in all five counties than the state and national averages *(Community)*
- Births to mothers without a high school diploma or GED is over 28% *(Community)*
- Attainment of secondary education is significantly lower in all of the Gateway jurisdiction *(Community)*
- The employment rate in all counties has remained stable over a five (5) year period *(Community)*
- Residential mobility illustrates individuals move within the same county with higher frequency than between county lines or from out of state, supporting internal data *(Community)*
- Bath, Menifee, Montgomery, & Morgan counties exceed the state average of veterans under the age of 65 years old *(Community)*
- Regulated child care capacity over a five (5) year period increased in all counties with the exception of Menifee, where it remained stable *(Community)*
- Montgomery and Rowan counties have the highest number of employer establishments and individuals that are employed along with the highest percentage of individuals 25+ with a high school diploma and access to broadband Internet *(Community)*
- Unemployment rates are significantly higher than the state average in all Gateway counties *(Community)*
- Health rankings for the Gateway counties have improved since the last community assessment, more closely mirroring the state average in the following areas: *(Community)*
 - life expectancy
 - adults that smoke
 - food insecurity


Qualitative Data:

- Board of Director and Policy Council self-assessment surveys illustrate members are pleased with the direction of the agency, feel a sense of meaningful involvement in the decision making processes, and have a clear understanding of their governance roles.
- Employee Surveys Results (*Capacity Building*)

 - confidence in leadership their supervisors knowledge and support
 - initial and ongoing training needs are sufficiently met
 - need technology to adequately communicate and perform assigned job tasks are adequately met

 - frequency of communication
 - communicating changes in a timely manner
- Community partner survey results support the need for higher paying jobs, sufficient housing, and substance abuse resources (*Community*)
- Consumer Survey/Forums (*Community*)
 - Surveys
 - The largest number of surveys results after staff were customers
 - Results illustrated satisfaction and confidence in Gateway staff and services
 - Education, health, affordable childcare, and employment were among the areas chosen
 - Those completing the survey were predominantly female
 - The survey results support the collected quantitative data
 - Forums
 - Consumers identified the need for employment, healthcare costs and transportation for seniors, affordable childcare, housing, after school activities, and grandparents raising grandchildren resources and support.
 - Consumers reported satisfaction with their interactions with employees noting; staff friendliness and respect.
 - Consumers noted the need for additional campaigns to increase community awareness of Gateway services, a “one-call” system to provide agency updates, and the amount of paperwork required for services.





Population Without Health Insurance Coverage in Kentucky


